4: Mark's gospel by Paul Gee on Friday 18th March at Amani Centre Paul Gee tells the gospel with an immediacy which surprises, challenges and engages the audience.

Paul uses the Shakespearian language of the authorised version, but because his performance is delivered without text, he captures the freshness and excitement of the oral tradition.

In the unfolding of the story, Jesus is shown to us not only as the son of Man, but also as a very real person: warm, passionate, approachable and witty. And also capable of the all-too-human qualities of irritation and frustration!

In this abridged version of Mark's gospel, we are presented with a compelling drama which invites the audience to question and look with fresh eyes.

6: Clerk for North Western Synod *Following the death of Kath Cross, Andy Braunston has served as Synod Clerk since March 2014. The Synod is now seeking nominations for an elected Synod Clerk to serve from October 2016 with a hand over period until October. **The closing date for nominations is 14th March 2016. Nominations should include why the nominator thinks the person has the necessary gifts and skills for the role and have the permission of the nominee.*** Application forms will then be sent to the nominees for them to complete.

Context

The Synod Clerk is elected from among the members of the Synod; and co-opted to the Synod if not a member when recommended for appointment. The duties relate to the functions of the Synod as set out in the Basis of Union and the Synod Guidelines. The term of office is normally three years with the possibility of a further term of three years. The position may be held by an ordained or lay person. The Clerk normally works at home and a laptop computer is provided, but regular attendance at the Synod Office is required. The Clerk must have good IT skills and be familiar with, or willing to learn, Outlook's email and diary functions. Travelling and other expenses are reimbursed. The workload of the clerk depends on what is going on within the Synod and if a Synod meeting, or Assembly, is near. On average the Clerk can expect to spend a day a week on Synod business.

The Clerk will be expected to develop a direct and mutually supportive relationship with the Moderator and an understanding of the responsibilities of the other Synod officers. She or he should have a reasonable understanding of the United Reformed Church as a whole and of current ecumenical and inter-faith developments and be willing and competent on occasion to represent the Synod or Assembly.

Duties & Responsibilities

- Lead on organisation of content and context of Synod meetings working with the Moderator and Executive Committee.
- Act as advisor to the Moderator, officers and Synod members on process issues and matters pertaining to the Basis of Union and Standing Orders especially at Synod Meetings
- Ensure appeals panels are convened in accordance with URC procedures.
- Attend Executive and Synod Resource Committee meetings, taking the minutes of the Executive.
- Take minutes of Synod meetings.
- Attend monthly Officers Meetings
- In consultation with the Moderator, prepare the agenda for the Synod Executive.
- Line manage the Office Manager/Moderator's PA and Assistant Secretary.
- Deal with regular correspondence and information directed to the Synod by the General Secretary or senior staff of the United Reformed Church, relating to General Assembly matters, Assembly committee programmes, Mission Council, etc.
- Serve as one of the Synod representatives to General Assembly. The Clerk has responsibility to oversee the arrangements for the Synod's representation at General Assembly and ensuring that representatives are briefed.
- Attend biannual meetings of the Synod Clerks.
- Serve as one of four NW members of Mission Council which meets twice a year for residential meetings.
